1. Terms and Conditions for Car Park Use

Under the terms and conditions for car park use, the car park user agrees to:

- 1.1 adhere to the Member Code of Conduct and to support the international interdisciplinary collegium of The Graduate Union with dignity, professionalism and respect;
- 1.2 to abide by all road rules and speed limits while driving and parking in the car park, and to be conscious of the needs and safety of other people and vehicles in the car park;
- 1.3 report all incidents, such as accidents involving other car park users, vehicles and the car park facility, to Graduate House staff in a timely manner and as soon as is practicable;
- 1.4 be safety and security conscious, reporting any security issues immediately and ensuring that the car park gate is closed after exiting the car park;
- 1.5 enter and use the car park at their own risk, ensuring that the car is parked and secured appropriately; and
- 1.6 release and indemnify The Graduate Union from any claim, which the car park user might otherwise have against The Graduate Union as a consequence of, in relation to, or in any way arising out of the use of The Graduate Union car park.

Under the agreement terms and conditions of this car park lease, The Graduate Union is and will not be liable for:

- 1.7 injury to the car park user or to anybody else in the car park;
- 1.8 damage to, destruction of, theft of, unauthorised entry to and delivery up of the car park user's vehicle or of any other authorised or unauthorised vehicle;
- 1.9 damage to, destruction of, theft of or delivery up of any property (including anything in or on the car park user's vehicle or any other vehicle), however caused; or
- 1.10 delivery of the car park user's vehicle to any person who takes your vehicle, whether authorised or not.
